

Completing a POA in favour of the 26778 Land Claim Action Group

- Signing a **Power of Attorney (POA)** is a legal instruction for the **26778 Land Claim Action Group (LCAG)** to represent your property in the upcoming court proceedings to defend your property against the Mekgareng Land Claim.
- Without a signed POA, LCAG may not represent your property.
- Only people who have valid POAs will benefit from any court order resulting from the court action.
- For representation, the POA is critical but is linked to having fully paid-up subscriptions.
- The court order is expected to degazette the claim on represented member deeds, remove the claim status, and free their land from the claim.
- Non-represented properties, after the LCAG achieves the final Court Order/Settlement Order, will need to have the claim status removed at their own expense when they wish to sell or raise a second bond or any other transaction requiring the Deeds Office interaction.

SPECIAL MANDATE AND POWER OF ATTORNEY GRANTED TO THE 26778 LAND CLAIMS ACTION GROUP
