DRAFT ORDER

AFTER HAVING hearing counsel for the parties the following order is made:

1. That the third and fourth respondents, namely the Mekgareng Community and the Makuwe Family are directed to file notices of appearance in terms of Rule 25(1) of the Land Claims Court Rules as well as a notice in terms of Rule 25(3)(a) containing the names and service addresses of all parties who filed notices of appearance within 10 days after date of this order.

2. That the third and fourth respondents are directed to file their responses to the referral report of the Regional Land Claims Commissioner within 15 days after complying with the order in paragraph 1 above.
3. That the 26778 Land Claims Action Committee and its members as well as the Department of Land Affairs are directed to file their responses to the Referral Report of the Regional Land Claims Commissioner and the responses by the third and fourth respondents within 15 (fifteen) days after receipt of the responses of the third and fourth respondents.
4. That the costs of the interlocutory application be costs in the main action.
